**RACING INCIDENTS**  
**(Race No. 9 - 16)**

**Track Condition** : **Good Going**  
**Penetrometer reading** : **2.8 Centimetres**  
**Railing Position** : **Railings fixed at average width of 3 Metres from 1600 Metres to the Winning Post from its original position.**

**1<sup>st</sup> Race: 09. The Balamuri Plate Div II - (About) 1400 Metres. Horses rated 00 to 25 (11 Runners):**

SAMARTH (S Mubarak) was examined at the Starting Gates by the Club's Veterinary Officer and it was found to have sustained bleeding injury on right hind outer cannon. Under the circumstances, it was permitted to be **withdrawn** on veterinary grounds before coming under Starter's Orders. Trainer Mr. P. Ruban was informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

BUNDELKHAND QUEEN (S.S. Khadri) jumped awkwardly inwards onto ANKUSH (Salman Khan) at the start.

It was observed that KNOTTY METHODS (Shah Alam) accidentally brushed the running rails approaching 1000 Metres.

Jockey S.S. Khadri, the rider of BUNDELKHAND QUEEN reported that his mount was hanging 'in' after entering the straight. Trainer Mr. Gnanashekar A was informed to take appropriate corrective measures before accepting with it again.

Jockey Sameer Qureshi, the rider of RICH STRIKE was reprimanded for dropping hands before passing the winning post.

Jockey Salman Khan, the rider of ANKUSH was reprimanded for dropping hands before passing the winning post.

Jockey Afsar Khan, the rider of NIMBUS SPIRIT was reprimanded for dropping hands before passing the winning post.

Jockey H. Rahul, the rider of PETTE'S CHOICE was fined **Rs.3,000/-** for the excessive use of whip on his mount during the race (**1<sup>st</sup> infringement**).

Jockey S.S. Khadri, the rider of BUNDELKHAND QUEEN was fined **Rs.3,000/-** for the excessive use of whip on his mount during the race (**1<sup>st</sup> infringement**).

Jockey Rafique S.K., the rider of BASIC INSTINCT was fined **Rs.3,000/-** for the excessive use of whip on his mount during the race (**1<sup>st</sup> infringement**).

NIMBUS SPIRIT (Afsar Khan) sustained bruise above left hind hock.

KNOTTY METHODS (Shah Alam) sustained small injuries inside left hind cannon.

BASIC INSTINCT (Rafique S.K.) sustained small injury on right flank fold.

**2<sup>nd</sup> Race: 10. The Prince Regent Plate - (About) 1100 Metres. Horses rated 20 to 45, 5 years old and over (12 Runners):**

KNOTTY IN BLUE (Rajesh K) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Mansoor Khan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey C.A. Brisson, the rider of AVIOTHIC was fined **Rs.2,000/-** for shifting out and causing interference to horses on his outside viz; ECO SYSTEM (Rafique S.K.) and SANDAL KING (Koshi Kumar) before passing the Red Marker Post.

It was observed that Jockey B. Darshan Anthony, the rider of COORG GENERAL had to steady his mount approaching 1000 Metres due to the crowding of the field.

It was observed that Jockey Koshi Kumar, the rider of SANDAL KING had to steady his mount approaching 900 Metres.

It was observed that CHOICE (Jitendra Singh) drifted out under pressure in the final 150 Metres of the Race.

Jockey Koshi Kumar, the rider of SANDAL KING was reprimanded for riding an indifferent race.

Jockey Rajesh. K, the rider of KNOTTY IN BLUE was reprimanded for riding an indifferent race.

Jockey Afsar Khan, the rider of PHOENIX GOLD was reprimanded for dropping hands before passing the winning post.

Jockey Rafique S.K., the rider of ECO SYSTEM was reprimanded for dropping hands before passing the winning post.

Jockey S.G. Prasad, the rider of KING SCARFACE was reprimanded for dropping hands before passing the winning post.

CHOICE (Jitendra Singh) was subjected to veterinary examination but no abnormality was reported.

ECO SYSTEM (Rafique S.K.) sustained clipped injury on left fore bulb of heel.

PHOENIX GOLD (Afsar Khan) sustained gum injury.

**3<sup>rd</sup> Race: 11. The Balamuri Plate, Div I - (About) 1400 Metres. Horses rated 00 to 25 (12 Runners):**

As Jockey Ankit Pal the declared rider of NATURAL QUEEN was certified medically unfit to ride, permission was granted to Trainer Mr. Mansoor Khan to substitute Jockey Shamaz Shareef to ride NATURAL QUEEN in the place of the declared rider.

EVERWIN (Ram Nandan Manji) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Sebastian J was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

It was observed that Jockey Lave Kumar, the rider of MISS SULTANA had to steady his mount approaching 1200 Metres, due to a closely packed field.

Jockey Ram Nandan Manji, the rider of EVERWIN was fined **Rs.3,000/-** for shifting 'in' and causing interference to the horses on his inside, viz., PERFECT HEART (K. Sai Kiran) and MISS SULTANA (Lave Kumar) approaching the 700 Metres.

Jockey N. Darshan, the rider of CAROLINA SPRINGS was fined **Rs.5,000/-** for not making sufficient effort to improve his position till rounding the bend and thereafter for not riding out his mount after entering the Straight.

Jockey A.R. Pradeep, the rider of LEAD SINGER was reprimanded for riding an indifferent race.

Jockey Shamaz Shareef, the rider of NATURAL QUEEN reported that his mount was hanging out in the final 300 Metres of the Race. The horse was subjected to veterinary examination and was reported to have sustained clipped injury on left hind tendon.

PERFECT HEART (K. Sai Kiran) sustained cut on right hind tendon region.

Routine sample was taken from the winner dk b m NATURAL QUEEN.

**4<sup>th</sup> Race: 12. The Kolar Plate, Div II - (About) 1400 Metres. Horses rated 20 to 45 (11 Runners):**

LOOKING FOR LADOO (S. Sachin) was permitted to be **withdrawn** from the above race.

It was observed that SANDS OF DUBAI (B. Dharshan Antony) turned its head towards the left as the Start was effected, thereby losing considerable ground at the Start. In view of its behaviour, Trainer Mr. Aditya K informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey Salman Khan, the rider of D ROMAN POWER was fined **Rs.5,000/-** for not making sufficient effort to improve his position till about entering the Straight and thereafter for not riding out his mount, in the Straight.

Jockey A.R. Pradeep, the rider of KALLANIA was fined **Rs.1,000/-** for travelling wide from 1200 Metres till about 500 Metres, for no apparent reason.

Jockey Shah Alam, the rider of KING D was fined **Rs.2,000/-** for shifting out and causing interference to SANDS OF DUBAI (B. Dharshan Antony), on his outside, which in turn passed it onto D ROMAN POWER ( Salman Khan) on its outside approaching the 300 Metres.

It was observed that SHE'S SO BEAUTIFUL (H. Rahul) completely stopped galloping and thereafter ran detached from the field in the final 300 Metres of the Race.

It was observed that KING D (Shah Alam) drifted out under pressure in the final 150 Metres of the Race.

Jockey Koshi Kumar, the rider of HERO WORSHIP was reprimanded for dropping hands before passing the winning post.

Jockey L. Alex Rozario, the rider of QUEENS CLIFF was reprimanded for dropping hands before passing the winning post.

KRISHVI (C. Umesh) sustained bruise on left chest wall behind the girth.

QUEENS CLIFF (L. Alex Rozario) sustained injury on right hind inside cannon.

**5<sup>th</sup> Race: 13. The Red Satin Plate - (About) 1200 Metres. Horses rated 60 and above (9 Runners).**

Permission was granted to Trainer Mr. Zulquarnain H to **withdraw** PERSIAN ROCK (A Ashhad Asbar) on veterinary grounds as it was found to have sustained clipped injury on left fore back of pastern. He was informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

VANDHIYATHEVAN (C Umesh – Drawn 6) jumped awkwardly outwards onto DRISANA (Anil Baandal – Drawn 7) thereby taking it out and BLUEMED (B. Nikhil – Drawn 8) jumped awkwardly inwards and bumped DRISANA (Anil Baandal) at the start, whereby Jockey Anil Baandal, the rider of DRISANA lost his left stirrup which he regained approaching 1000 Metres.

Jockey B. Nikhil, the rider of BLUEMED was reprimanded for travelling wide rounding the final bend for no apparent reason.

Jockey Koshi Kumar, the rider of RAFFINATO was reprimanded for travelling wide rounding the final bend for no apparent reason.

An Objection was lodged by Jockey Anil Baandal, the rider of DRISANA, placed second by the Judge against Jockey C Umesh, the rider of VANDHIYATHEVAN, placed first by the Judge, for "At the Start, horse No. 4 (VANDHIYATHEVAN) from Gate "6" bumped me, whereby I lost my left Stirrup and dropped back to last position. I had to come from last position which cost me a certain Race". The Stewards held an enquiry immediately after the Race and examined Jockey Anil Baandal and Jockey C Umesh. The Stewards also examined Jockey B Nikhil, the rider of BLUEMED. After due deliberations and after repeatedly watching the CCTV replay of the Race, the Stewards decided to **Overrule** the objection.

Jockey C. Umesh, the rider of VANDHIYATHEVAN was fined **Rs.3,000/-** for not exercising sufficient control over his mount, thereby allowing it shift out and cause interference to DRISANA (Anil Baandal) at the start.

DRISANA (Anil Baandal) sustained superficial bruise under the girth on right chest wall.

**6<sup>th</sup> Race: 14. The Varahi Trophy - (About) 1200 Metres. Horses rated 40 to 65 (12 Runners).**

RIVER OF GOLD (Hindu Singh) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Ruban P was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

ISABELLE (Brijesh Kumar V) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Vinesh V Naik was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey Brijesh Kumar. V, the rider of ISABELLE was fined **Rs.3,000/-** for not making sufficient effort to improve his position from 1000 Metres till about 400 Metres.

It was observed that the left side cheek pieces on SHERPA (L. Alex Rozario) came off passing the 500 Metres. Hence, Trainer Mr. J.S. Pillay was fined **Rs.3,000/-** for his negligence in failing to fasten the side cheek pieces properly.

Jockey Shyam Kumar (Jr), the rider of KALLU SAKKARE was reprimanded for travelling wide from 500 Metres till about the winning post.

Jockey A. Ashhad Asbar, the rider of TAQDEER reported that his mount was not galloping fluently in the final 200 Metres of the Race.

PHOENOMENON (Sah Farid Ansari) sustained small cut on left hind outer cannon.

Routine sample was taken from the winner b g SHERPA.

**7<sup>th</sup> Race: 15. The Kolar Plate, Div I - (About) 1400 Metres. Horses rated 20 to 45 (8 Runners):**

Permission was granted to Trainer Mr. Suraj Prasad Shaw to **withdraw** CLOUD JUMPER on veterinary grounds as it was found to be suffering from colic. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

Jockey Faiz, the rider of POLAR WIND reported to the Starter, once the horse reached Starting Gates, that the saddle on his mount was not fastened properly. At his insistence and the handlers tried to re-saddle the horse but due to the extremely fractious behavior of the horse behind the Gates, it could not be re-

saddled. Under these circumstances, it was permitted to be **withdrawn** before coming under Starter's Orders.

CODE OF HONOUR was examined at the starting gates by the Club's Veterinary Officer and it was found to be trotting lame on right hind. Under the circumstances, it was permitted to **withdrawn** on veterinary grounds before coming under Starter's Orders. Trainer Mr. Bobby. Mwas informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

COSETTE was extremely fractious inside the Starting Stalls whereby it ducked under the stalls. The horse was examined by the Club's Veterinary Officer and it was found to have sustained bleeding gum injury. Under the circumstances, it was permitted to **withdrawn** on veterinary grounds before coming under Starter's Orders. Trainer Mr. Saddam Iqbal was informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

MARENAD BEAUTY (S.G. Prasad) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Dhyan Subbaiah K was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey Sah Farid Ansari, the rider of BOLD SHOW reported that his mount was running erratic in the final 250 Metres of the Race.

Jockey C.A. Brisson, the rider of REIGN OF TERROR reported that his mount was hanging out throughout the race. Trainer Mr. Mandanna K.S. was informed to take appropriate corrective measures before accepting with it again.

It was observed that MARENAD BEAUTY (S.G. Prasad) ran detached from the field. Trainer Mr. Dhyan Subbaiah was informed to ensure better performance of his charge in future.

Routine sample was taken from the winner b g MIND GAMES.

**8<sup>th</sup> Race: 16. The Nagamangala Plate - (About) 1400 Metres. Horses rated 40 to 65, 5 years old and over (10 Runners).**

Trainer Mr. J Sebastian was fined a sum of **Rs.10,000/- (Rupees Ten Thousand Only)** by the Stewards, for entering his charge DIAMOND AND PEARLS to run in the above Race, when it was under Veterinary Ban.

Permission was granted to Trainer Mr. Suraj Prasad Shaw to **withdraw** AR SPRINT QUEEN (Anil Baandal) on veterinary grounds as it was found to be lame on right hind due to muscular cramps. He was informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

Permission was granted to Trainer Mr. Ruban. P to **withdraw** SERRANO on veterinary grounds as it was found to have fascial urticaria. He was informed that

he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

Jockey Bharat Mal, the rider of GEMINI was fined **Rs.1,000/-** for shifting 'in' and causing interference to ULTIMATE BLUES (Arvind Kumar.N) on his inside at the start.

Jockey Bharat Mal, the rider of GEMINI was fined **Rs.1,000/-** for shifting out and taking out AURELE (Neeraj Rawal) on his outside passing the 1000 Metres.

Jockey Ankush, the rider of TIME FOR VICTORY was fined **Rs.2,000/-** for the undesirable practice of hitting the horse with the hands, in the final 100 METres of the Race.

Jockey Bharat Mal, the rider of GEMINI reported that his mount was hanging 'in' throughout the race. The horse was subjected to veterinary examination. On examination, it was found to have small injury on left oral commissure. Trainer Mr. Bobby M was informed to take appropriate remedial measures before accepting with it again.

Jockey B. Nikhil, the rider of VAYU reported that his mount stopped galloping in the final 250 Metres of the Race.

An Objection was lodged by Jockey Neeraj Rawal, the rider of AURELE, placed second by the Judge against Jockey Bharat Mal, the rider of GEMINI, placed first by the Judge, for "crossing the 1000 Metre marker, horse No. 7 GEMINI drifted on to me, due to which I had to travel 5 to 7 horses wide. My horse being an 8 year old, took time to gather momentum, the verdict being a nose, this cost me a certain Race". The Stewards held an enquiry immediately after the Race and examined Jockey Neeraj Rawal and Jockey Bharat Mal. After due deliberations and after repeatedly watching the CCTV replay of the Race, the Stewards decided to **Overrule** the objection.

EVERWIN (Ram Nandan Manji) – Was slowly away and lost few lengths.

**4<sup>th</sup> Race: 12. The Kolar Plate Div. II (About) 1400 Metres:**

SANDS OF DUBAI (B Darshan Anthony) – Threw its head towards left while jumping out and lost few lengths.

**5<sup>th</sup> Race: 13. The Red Satin Plate (About) 1200 Metres:**

**6<sup>th</sup> Race: 14. The Varahi Trophy (About) 1200 Metres:**

ISABELLE (Brijesh Kumar V) } – Both were slowly away and lost few  
RIVER OF GOLD (Hindu Singh) } lengths.

**7<sup>th</sup> Race: 15. The Kolar Plate Div. I (About) 1400 Metres:**

POLAR WIND (Faiz) – Was extremely fractious at the gate and did not allow for re-saddling. Hence permitted to be withdrawn.

COSETTE (B Nikhil) – Was permitted to be withdrawn on veterinary grounds before coming under the Starters Order as the mare got hurt inside the stall.
