RACING INCIDENTS

(Race No. 83 - 90)

Weather : Clear
Track Condition : Good Going
Penetrometer reading : 2.7Cms
Positioning of Railings : Railings are fixed at an average width of 3 Metres from 1600 Metres to the Winning post from its original position.

1st Race: 83. The Star Angel Plate – Div. II (About) 1200 Metres. Horses rated 00 to 25 (8 Runners):

SARO BIRD (V R Jagdeesh) was examined at the Starting gates by the Club's Veterinary Officer and was found to be trotting lame on left fore. Under the circumstances it was permitted to be **withdrawn** on veterinary grounds before coming under Starter's Orders. Trainer Mr. G T Surender was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

D FIGHTER (S Brahmmesh) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Vishal Yadav was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

It was observed that ANUSHTUBHA (S Antony Raj) accidentally stumbled passing the 600 Metres.

Jockey S Antony Raj, the rider of ANUSHTUBHA reported that his mount was trying to run out in the straight. The horse was impounded for veterinary examination and was found to be lame on right fore. Trainer Mr. Rakesh was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that BUNDELKHAND QUEEN (Md Sameer) burst its blood vessels during the race. Trainer Mr. Mansoor Khan was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

FESTIVE STAR (Koshi Kumar) was observed to be hanging out in the straight. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Ashwin Rao S was informed to take appropriate corrective measures before accepting with it again.

2nd Race: 84. The Aperitivo Plate (About) 1400 Metres. Horses rated 20 to 45, 6 years old and over (10 Runners):

Permission was granted to Trainer Mr. Mansoor Khan to **withdraw** STAR IS BACK (Aman) on veterinary grounds as it was suffering from colic. He was informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

CASTANEDA (Madhu Sudhan S) planted, lost many lengths at the start and ran detached from the field thereafter. In view of its behaviour, Trainer Mr. M Bobby was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

FOREST VIEW (Prabhu Kumar M) was slowly away, lost few lengths at the start and ran detached from the field thereafter. In view of its behaviour, Trainer Mr. Monnappa C D was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

It was observed that PETTE'S CHOICE (H Rahul) could not get a clear run between the 450 Metres and 300 Metres due to a tightly packed field.

It was reported after the race that EYE THE MIND (R Vaibhav) pulled up lame on right fore. Trainer Mr. M Pratap Kamath was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

An enquiry is being held into the reversal of form and the resultant improved performance CODE OF HONOUR, trained by Mr. Bobby M and ridden by Jockey A Ramu, the winner of the above race as compared to its previous run in Race No. 51 of the Mysore winter Races 2024-25, i.e., The Nelamangala Plate (About) 1400 Metres, for horses rated 00 to 25 run on Friday, 3rd January 2025 when ridden by Jockey M Prabhakaran it ran unplaced.

Routine Sample was taken from analysis from the winner b g CODE OF HONOUR.

3rd Race: 85. The Star Angel Plate – Div. I (About) 1200 metres. Horses rated 00 to 25 (9 Runners):

Trainer Mr. Ashwin S Rao was fined **Rs.5,000/-** for having sent his charge RICH STRIKE (Koshi Kumar) directly to the Starting gates with a Riding Boy without obtaining prior permission of the Stipendiary Stewards for the same.

FERONIA (J Paswan) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Rakesh was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey Md. Imran Ashraf, the rider of AMRON TIGRESS was fined **Rs.2,000/-** for shifting out under the use of whip and taking out D GOLDEN CUP (Vinod Shinde) on his outside between the 400 Metres and 300 Metres of the race.

RICH STRIKE (Koshi Kumar) sustained deep clipped injury on right hind below hock.

Routine sample was taken for analysis from the winner, b m VIJAYA STAR.

4th Race: 86. The Indi Plate (About) 1200 Metres. Horses rated 20 to 45 (12 Runners):

THE SIZABLE (Afsar Khan) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Santosh S Rao was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

AARADHANA (A Ayaz Khan) planted, lost many lengths at the start and ran detached thereafter. In view of its behaviour, Trainer Mr. Bipin V Salvi was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

TENDRILS OF POWER (Rajesh K) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. P Ruben was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey Vaibhav R, the rider of TO HOT TO TOUCH, was reprimanded for coming in and inconveniencing horses on his inside, viz., FURIOUS FUN (Rahil Akhtar) and EIFFEL TOWER (Siddaraju P), soon after the Start and thereafter, for coming in and inconveniencing DRISANA (Vinod Shinde) on his inside, before passing the Red Marker Post.

It was observed that THE SIZABLE (Afsar Khan) accidentally stumbled passing the 650 Metres.

Jockey Vinod Shinde, the rider of DRISANA Was fined **Rs.5,000/-** for the excessive use of the whip on his mount during the race (**2nd Infraction**).

An enquiry is being held into the running and riding of DALI'S GOLD, trained by K Somashekar and ridden by Jockey Salman Khan in the above race.

Routine Sample was taken from analysis from the winner b m DRISANA.

5th Race: 87. The Sriharikota Plate – Div. II (About) 1100 Metres. Horses rated 40 to 65. (No whip) (8 Runners):

FLYING FALCON (Rajesh K) was examined at the Starting gates by the Club's Veterinary Officer and was found to be bleeding from the nostrils. Under the

circumstances it was permitted to be **withdrawn** on veterinary grounds before coming under Starter's Orders. Trainer Mr. Bipin V Salvi was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

TWILIGHT FAME (A Ayaz Khan) planted and did not take any practical part in the race. In view of its behaviour, Trainer Mr. K Somashakar was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **Two Mock Races** on Race Days on the Race Track.

PROUD (Salman Khan) was slowly away, did not raise a fluent gallop, lost many lengths at the start, and ran detached thereafter. In view of its behaviour, Trainer Mr. Ranjeet Shinde was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

INEFFABLE (Siddaraju P) threw its head up while jumping out of the Starting Gates.

6th Race: 88. The Air Force Trophy (About) 1200 Metres. For Maiden Horses, 3 years old only (6 Runners):

As Jockey A Ashhad Asbar was certified medically unfit to ride, permission was granted to Trainer Mr. C D Monnappa to substitute Jockey Dhanu Singh Deora to ride COSMIC TOUCH in place of the declared rider.

Jockey K Nazil was fined **Rs.2,000/-** for not failing to fulfill his riding engagement after having accepted to ride NATURAL LOOK in the above race. Subsequently permission was granted to Trainer Mr. Mansoor Khan to substitute Jockey Koshi Kumar to ride NATURAL LOOK in place of the declared rider.

NATURAL LOOK (Koshi Kumar) swerved left after jumping out whereby the rider got unbalanced and was dislodged from his mount. In view of its behaviour, Trainer Mr. Mansoor Khan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Routine Sample was taken from analysis from the winner b c COSMIC TOUCH.

7th Race: 89. The Ellora Plate (About) 1200 Metres. Horses rated 80 and above(7 Runners):

Jockey Koshi Kumar, the rider of VIJAYA FALCON was reprimanded for shifting out and inconveniencing the horses on his outside viz. SEA THE SUN (Vinod Shinde) and THE PROTECTOR (Siddaraju P) on his outside passing the 800 Metres.

Surprise Sample was taken from analysis from the dk b g VIJAYA FALCON.

Routine Sample was taken from analysis from the winner b g MYSTIC BOND.

8th Race: 90. The Sriharikota Plate – Div. I(About) 1100 Metres. Horses rated 40 to 65. No whip (8 Runners):

As Jockey A Ayaz Khan, the rider of D ROMAN REIGNS was certified medically unfit to ride, and as no suitable substitute rider was available, permission was granted to Trainer Mr. Bipin V Salvi to **withdraw** D ROMAN REIGNS from the above race.

Trainer Mr. Bobby M was fined **Rs.2,000/-** for sporting Red Hood on his charge, RAPIDUS (Prabhakaran M) in the above Race, for which prior permission had not been obtained. However, Red Hood was removed before the horse left the Paddock.

MIRACULOUS GIRL (Siddaraju P) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Ranjeet Shinde was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

TWILIGHT FAME (A Ayaz Khan) – Planted and did not raise a fluent gallop after jump out and took no practical part in the race. The Starting Stall Certificate is revoked.

NATURAL LOOK (K Nazil) – After jump out swerved to left dropped the rider and took no part. The Starting Stall certificate is revoked.

RACE NO. 08: THE VIRIJA PLATE – DIV. II (ABOUT) 1100 METRES.
HORSES RATED 00 TO 25 CONFINED TO MYSORE BASED HORSES:

Jockey Afsar Khan was questioned by the Stipendiary Stewards in the presence of Trainer Mr. Santosh Rao as to his riding on his mount THE ARTERY, in the above Race. After due examination of Jockey Afsar Khan and not being satisfied by the explanations tendered by him, the Stipendiary Stewards decided as follows;

- a) To fine him a sum of **Rs.5,000/- (Rupees Five Thousand only)** for not making sufficient effort to improve his position while rounding the bend for not infusing adequate vigour in riding out his mount, in the Straight;
- b) To caution him to be more judicious while riding out his mounts in future and that a similar manner of riding on his mounts in future would entail him being reported to the Stewards for appropriate action; and
- c) To note the explanations tendered by Trainer Mr. Santosh Rao S.

RACE NO. 77: THE BABABUDAN GIRI PLATE (ABOUT) 1100 METRES. FOR INDIAN HORSES 3 YEARS OLD ONLY:

The Stipendiary Stewards reported Trainer Mr. M Eshwer to the Stewards vide Charge Sheet No. 350 dated 3rd February, 2025, for breach of Rule No. 114 (b) (i) of the Mysore Race Club Ltd., Rules of Racing, pertaining to the running of his charge PARK WEST in the above Race, in that, as a licensed Trainer, "a)

After making the change of equipment by switching off Rubber Basket Bit and switched on to Hanging Bit on your charge, PARK WEST, in Race No. 77, you have not shown it in a MOCK RACE, to check whether the change of equipment made by you has suited your charge and has corrected its habit to drift out in the Straight; **b)** Instead, after the change of equipment, you have directly run it in Race No. 77, wherein, despite the best efforts of the rider to keep it on a straight course, the horse veered out alarmingly and finished the race on the outer sand track thus losing the above Race; **c)** The closing Bookmaker Odds for the above horse, viz., PARK WEST, was (25/100)". The Stewards, at their meeting held immediately after the last Race on 6th February, 2025, examined Trainer Mr. M Eshwer. After detailed and due deliberations, the Stewards decided as follows;

a) To fine Mr. M Eshwer a sum of Rs. **25,000/- (Rupees Twenty Five Thousand only)** for breach of Rule No. 114 (b) (i) of the Mysore Race Club Ltd., Rules of Racing, pertaining to the running of his charge PARK WEST in the above Race; and

b) To severely caution him that a repetition of a similar manner of offence in future, would be dealt with a much harsher punishment.

c) Trainer Mr. M Eshwer was informed of his right to appeal.

RACE NO. 82: THE COCHIN PLATE (ABOUT) 1600 METRES. HORSES RATED 40 TO 65:

The Stipendiary Stewards reported Jockey Akash Agarwal to the Stewards vide Charge Sheet No. 351 dated 3rd February, 2025, for breach of Rule No. 161 (i) of the Mysore Race Club Ltd., Rules of Racing, for dangerous Riding on his mount, THALAIVAA, in the above Race, in that, as a rider of THALAIVA, You came in and caused severe interference to AMAZING ARISE (H Rahul) on your inside, which went onto, SIR CALCULUS (Vinod Shinde) and POLAR WIND (Koshi Kumar) on its inside and as such, the rider of POLAR WIND had to check his mount and fall back, approaching the 700 Metres and thereafter, for coming in and causing severe interference to MAGIC CIRCLE (Anil Baandal) on your inside due to which the rider of MAGIC CIRCLE also had to check his mount and fall back along the rails, passing the 350 Metres of the above Race". The Stewards, at their meeting held immediately after the last Race on 6th February, 2025, examined Jockey Akash Agarwal. After detailed and due deliberations, and after repeatedly viewing the CCTV replay of the above Race, the Stewards decided as follows;

a) If a Jockey's License were to be granted to Jockey Akash Agarwal, for the year 2025-26, the same shall be suspended for the **first four days of the Mysore Summer Races 2025, [the dates shall be notified later]**, for breach of Rule No. 161 (i) of the Mysore Race Club Ltd., Rules of Racing, [Dangerous Riding] on his mount THALAIVAA, in the above Race; and

b) To severely caution him that a repetition of a similar manner of riding in future, would be dealt with in a much harsher punishment.

c) Jockey Akash Agarwal was informed that he was permitted to ride work and was also informed of his right to appeal.
