RACING INCIDENTS

(Race No. 25 - 32)

Weather	: Partly Cloudy
Track Condition	: Good Going
Penetrometer reading	: 3.1 cms
Positioning of Railings	: Railings fixed at an average width of 1.5 Metres from 1600 Metres to the Winning Post from its original position

1st Race: 25. The Bijapur Plate – Div. II (About) 1200 Metres. Horses rated 00 to 25 (14 Runners):

Jockey S Antony Raj, the rider of DIVA IN GOLD reported that his mount was trying to run out in the straight. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Surender G T was informed to take appropriate corrective measures before accepting with it again.

Jockey Dhanu Singh Deora, the rider of VIJAYA SURABHI reported that his mount was hanging 'in' in the final 400 Metres of the race. The horse was impounded for veterinary examination but due to its highly fractious behaviour it could not be examined. Trainer Mr. P C Tejaswi was informed to take appropriate corrective measures before accepting with it again.

Jockey A Ayaz Khan, the rider of MASTERS MIND, was questioned by the Stipendiary Stewards pertaining to his riding on his mount, in the above Race. The Jockey reported that his mount was hanging 'in' after entering the straight and as such, he could not ride out in the closing stages of the Race. The horse was impounded for veterinary examination and the examination of the mouth of the horse revealed sharp molars. Hence Trainer Mr. M Bobby was fined **Rs.3,000/-** for his negligence **(1st Infraction)**.

Surprise sample was taken for analysis from b f VIJAYA SURABHI.

2nd Race: 26. The KRS Plate (About) 1400 Metres. Horses rated 20 to 45, 5 years old and over (9 Runners):

As Jockey Akash Agarwal, the declared rider of SAN VINTO was certified medically unfit to ride, permission was granted to Trainer Mr. Ashwin S Rao

to substitute Jockey Nazerul Alam to ride SAN VINTO in place of the declared rider.

AIRVELOCITY (H Zeeshan) was examined at the Starting Gates by the Club's Veterinary Officer and was found to be trotting lame on left fore. Under the circumstances it was permitted to be **withdrawn** before coming under Starter's Orders. Trainer Mr. Md Sajid Qureshi was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g VANDAN.

3rd Race: 27. The Bijapur Plate – Div. I (About) 1200 Metres. Horses rated 00 to 25 (13 Runners):

Jockey Nazerul Alam replaced the indisposed Jockey Akash Agarwal on JAGUAR.

It was observed that COUNTRY'S MAJOR (Likith Appu K G) drifted out alarmingly despite the best efforts of the Jockey to keep it on an even course and ended up racing on the outer sand track after passing the 900 Metres and finished the race on the outer sand track. The horse was impounded for veterinary examination but no abnormality was reported. In view of its behaviour, Trainer Mr. Feroz M Khan was informed to take appropriate corrective measures and that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race day on the race track.

Jockey K Sai Kiran, the rider of THE ARTERY reported that his mount was trying to run out throughout the race. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Santosh S Rao was informed to take appropriate corrective measures before accepting with it again.

SHOOTING VENUS (Arshad Alam) sustained small injury on right hind coronet.

JAGUAR (Nazerul Alam) sustained injury on right hind chestnut.

4th Race: 28. The Pandavapura Plate - Div. II (About) 1200 Metres. Horses rated 20 to 45 (15 Runners):

LUCKY SUN (L Alex Rozario) jumped awkwardly outwards, at the start.

It was observed that SWEETER THAN HONEY (S Antony Raj) was trying to run out approaching the 800 Metres and thereafter, ran detached from the

field. Trainer Mr. Ashwin Rao S was informed to take appropriate corrective measures before accepting with it again and also ensure better performance of his charge in future.

DADDY'S GIRL (P Kiran Rai) was impounded for veterinary examination and the examination of the mouth revealed sharp molars. Hence Trainer Mr. Girinath C was fined **Rs.3,000/-** for his negligence **(1st Infringement)**.

LUCKY SUN (L Alex Rozario) sustained gum injury.

FUN AND LAUGHTER (Likith Appu K G) sustained bleeding injury on right fore front of coronet.

Routine Sample was taken for analysis from the winner ch g FUN AND LAUGHTER.

5th Race: 29. The Mekedaatu Plate (About) 1200 Metres. Horses rated 40 to 65, 5 years old and over (14 Runners):

Jockey M S Deora, the rider of AMAZING SAFARI reported that his mount was hanging out after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Md. Sajid Qureshi was informed to take appropriate corrective measures before accepting with it again.

Trainer Mr. Tejaswi P C was questioned as to the vastly improved performance of his charge, PERFECT PERFECTO, ridden by Jockey Dhanu Singh Deora in the above race as compared to its previous run in Race No.13 of the Mysore Winter Races 2022-23, i.e., The Big Deal Plate, Div II - (About) 1400 Metres, for horses rated 40 to 65 run on, Saturday, 26th November, 2022 when ridden by Jockey A Ayaz Khan it ran unplaced. After due enquiry and not being satisfied with the explanations tendered by Trainer Mr. Tejaswi P C, he was fined a sum of **Rs.10,000/ -(Rupees Ten Thousand only)**, for the vastly improved performance of his charge, PERFECT PERFECTO, ridden by Jockey Dhanu Singh Deora, in the above Race.

Routine Sample was taken for analysis from the winner b r PERFECT PERFECTO.

6th Race: 30. The Nagarjunsagar Trophy (About) 1200 Metres. Horses rated 60 and above (15 Runners):

WILD SPELL (Nikhil Naidu) jumped awkwardly inwards and inconvenienced TRACER BULLET (Janardhan Paswan), on its inside, soon after jumping out of the Starting Gates.

TURF LEGEND (Ahsan Qureshi) swerved left after jumping out of the Starting Gates, did not raise a fluent gallop and ran detached from the field, thereafter. In view of its behaviour, Trainer Mr. Md Sajid Qureshi was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race day on the race track.

WILD SPELL (Nikhil Naidu) was impounded for veterinary examination but no abnormality was reported.

7th Race: 31. The Srirangapattana Plate (About) 1600 Metres. Horses rated 40 to 65 (10 Runners):

DRUSILLA (A R Pradeep) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Joseph B Awale was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump out** on a Starting Gate practice day.

Jockey Arshad Alam, the rider of TIA MARIA was fined **Rs.2,000/-** for shifting in and causing interference to HEROISM (M S Deora), on his inside, approaching the 200 Metres.

It was observed that the saddle on IMPERIUS (K Sai Kiran) slightly shifted ahead approaching the 1400 Metres. After due examination of the equipment, which was found to be in serviceable condition, no action was taken beyond noting the incident.

Routine Sample was taken for analysis from the winner b f AMOZONIA.

8th Race: 32. The Pandavapura Plate – Div. I (About) 1200 Metres. Horses rated 20 to 45 (15 Runners):

GOD'S POWER (Shamaz Shareef) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. M Bobby was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

It was reported after the race that DREAM MACHINE (Siddaraju P) burst its blood vessels during the race. Trainer Mr. Santosh Rao S was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

RACE NO. 127: THE ROYAL WESTERN INDIA TURF CLUB LTD., TROPHY (ABOUT) 1200 METRES. HORSES RATED 40 TO 65, 5 YEARS OLD AND OVER:

The Stipendiary Stewards reported Trainer Mr. Vinesh V Naik to the Stewards, vide Charge Sheet No. 306, dated 4th December, 2022 for breach of Rule No.114 (b)(i) read with Rule No. 202 (i) of the Mysore Race Club Limited Rules of Racing and Calendar Notification under the heading "NOTICE TO TRAINERS AND JOCKEYS" pertaining to the saddling of his charge, D FIRE, in the above Race; In that, he allowed Race horse Owner, Mr. Imran Khan to saddle his charge, in the above Race; The Stewards, at their meeting held on Wednesday, 7th December, 2022, examined Trainer Mr. Vinesh V Naik; After due deliberations, the Stewards decided as follows;

- a) To fine Trainer Mr. Vinesh V Naik a sum of **Rs.10,000/- (Rupees Ten Thousand only)** for breach of Rule No.114 (b)(i) read with Rule No. 202 (i) of the Mysore Race Club Limited Rules of Racing and Calendar Notification under the heading "NOTICE TO TRAINERS AND JOCKEYS" pertaining to the saddling of his charge, D FIRE, in the above Race [He was informed of his right to appeal]; and
- b) To caution him that a repetition of a similar manner of offence in future, would be dealt with appropriately by them.

The Stipendiary Stewards reported Race Horse Owner Mr. Imran Khan to the Stewards, vide Charge Sheet No. 307, dated 4th December, 2022 for breach of Rule No. 202 (i) of the Mysore Race Club Limited Rules of Racing [Improper Practice] pertaining to the saddling of D FIRE, in the above Race; In that, he saddled the said horse, trained by Mr. Vinesh V Naik in the above Race, without the authorization of the Trainer nor the permission of the Stipendiary Stewards; The Stewards, at their meeting held on Wednesday, 7th December, 2022, examined Race Horse Owner, Mr. Imran Khan; After due deliberations, the Stewards decided as follows;

- a) To fine Race Horse Owner Mr. Imran Khan a sum of **Rs.10,000/-** (**Rupees Ten Thousand only**) for breach of Rule No. 202 (i) of the Mysore Race Club Limited Rules of Racing [Improper Practice] pertaining to the saddling of D FIRE, in the above Race [He was informed of his right to appeal]; and
- b) To caution him that a repetition of a similar manner of offence in future, would result in the cancellation of his Ownership.

The Stipendiary Stewards reported Race Horse Owner Mr. Imran Khan to the Stewards, vide Charge Sheet No. 309, dated 4th December, 2022 for breach of Rule No. 202 (xii) read with Rule No. 19 of the Mysore Race Club Limited Rules of Racing [Threatening and insulting behavior against an Official of the Club]; In that he has, in an inebriated state, threatened and misbehaved with an Official of the My.R.C. Ltd., for no apparent reason. The Stewards, at their meeting held on Wednesday, 7th December, 2022, examined Race Horse Owner, Mr. Imran Khan and the Official concerned; After due deliberations, the Stewards decided as follows;

- a) To seek an unconditional apology, in writing, from the Race Horse Owner, Mr. Imran Khan, to the Official of the Club; and
- b) To caution him that a repetition of a similar manner of offence in future, would result in the cancellation of his Ownership.
