1st Race: 57. The Himalayas Plate (About) 1200 Metres. Indian horses 3 years old only (5 Runners):

SELMA (Anil Baandal) veered out slightly to the left, soon after jumping out of the Starting Gates.

2ndRace: 58. The Antequera Plate (About) 1400 Metres. Horses rated 20 to 45, 6 years old and over (8 Runners):

LUCKY POINT (Rahil Akhtar) jumped awkwardly outwards, at the Start.

EYE THE MIND (Angad) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Pratap Kamath was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey Angad, the rider of EYE THE MIND was fined <u>Rs.5,000/-</u> for the excessive use of the whip on his mount in the above race $(2^{nd} Infringement)$.

Routine Sample was taken for analysis from the winner b m MINX.

3rdRace: 59. The Crystal Man Plate (About) 1400 Metres. Horses rated 00 to 25, 6 years old and over (13 Runners):

MORGANITE (Shreyas Singh) was extremely fractious and bolted on the way to the Starting gates. Under the circumstances it was permitted to be **withdrawn** before coming under Starter's Orders.

D FIGHTER (Ajeet Kumar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Vishal Yadav was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey R N Darshan, the rider of COUNTRY MAGIC was reprimanded for not maintaining a straight course thereby cutting across the field sharply soon after the start.

Jockey Rajesh K, the rider of WIND POWER was reprimanded for shifting out and taking out VANDAN (V R Jagadeesh) on his outside rounding the final bend.

MIRACLE HONEY (Koshikumar) accidentally brushed the running rails approaching the 1100 Metres and drifted out after passing the final 300 Metres despite the best efforts of the Jockey to keep it on an even course and finished the race on the outer portion of the grass track. The Horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Ashwin S Rao was informed to take appropriate corrective measures before accepting with it again.

It was reported after the race that AGAINST ALL ODDS (Sham Kumar) apparently lost its left hind shoe during the race.

ISLAND LASS (Faiz) sustained bleeding injury on left hind outer cannon.

FESTIVE STAR (Akash Agarwal) sustained bruise on right hind back of fetlock.

Routine Sample was taken for analysis from the winner b m MIRACLE HONEY.

4thRace: 60. The Sirsi Plate - Div. II(About) 1200 Metres. Horses rated 20 to 45 (11 Runners):

NOBLE PURSUIT (Ajeet Kumar) was extremely fractious inside the gates whereby its left hind leg got stuck on the platform for a considerable period of time. Under the circumstances it was permitted to be **withdrawn** before coming under Starter's Orders.

DALHOUSIE (Akash Agarwal) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Aditya K was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

STREET SENSE (R N Darshan) jumped awkwardly inwards and bumped KALASHNIKOV (Angad) soon after jumping out of the Starting Gates.

BEAUTIFUL BLOOM (Madhu Sudhan S) accidentally brushed the running rails approaching the 1000 Metres.

Jockey Madhu Sudhan S, the rider of BEAUTIFUL BLOOM was fined **Rs.1,000/**-for shifting out and taking out HALCHEMENY (M Rajesh Kumar) on his outside passing the 750 Metres.

Jockey Angad, the rider of KALASHNIKOV reported that his mount was hanging out throughout the race. The horse was impounded for veterinary examination and the examination of the mouth revealed ulcer at left oral commissure. Trainer Mr. S Ramesh was informed to take appropriate remedial measures before accepting with again.

Routine Sample was taken for analysis from the winner ch f TOO HOT TO TOUCH.

5thRace: 61. The Dr. Ishwari G K Balakrishnan Memorial Trophy (About) 1400 Metres. Horses rated 60 and above(9 Runners):

MYSTIC BOND (Rajesh K) accidentally brushed running rails approaching the 1000 Metres.

Jockey LikithAppu K G, the rider of GOLD KITE reported that his mount was not galloping fluently throughout the race and also ran detached after passing the final 300 Metres. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Aditya was advised to ensure better performance of his charge in future.

Jockey Rajesh K, the rider of MYSTIC BOND reported that his mount was trying to run out in the straight. The horse was impounded for veterinary examination and the examination of the mouth revealed sharp molars. Trainer Mr. Pratap Kamath was fined **Rs.3,000/-** for his negligence.

CAVAROZZI (Faiz) ran detached after rounding the final bend. Trainer Mr. C D Monnappa was advised to ensure better performance of his charge in future.

It was reported after the race that RED SEA STAR (Anil Baandal) pulled up lame on left fore. Trainer Mr. Ruben P was informed that he must produce a <u>Fitness</u> <u>Certificate</u> from the Club's veterinary Officer before accepting with it again.

It was reported after the race that DEUS EX MACHINA (A Prakash) burst its blood vessels during the race. Trainer Mr. Ranjeet Shindewas informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

Trainer Mr. Ruben P was fined Rs.10,000/- for discrepancy in shoeing in respect of his charge RED SEA STAR in the above race $(2^{nd} Infringement)$.

6thRace: 62. The Bold Majesty Plate (About) 1600 Metres. Horses rated 40 to 65(9 Runners):

As Jockey Ajeet Kumar, the declared rider of DIVINE RAY was certified medically unfit to ride after his ride in the 5th race and as no suitable substitute rider was available, permission was granted to Trainer Mr. Ruben P to **withdraw** DIVINE RAY from the above race.

INDIAN PATRIOT (Akash Agarwal) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Aditya K was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

WHAT IS THIS (M Rajesh Kumar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S Ramesh was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey Koshi Kumar, the rider of THALAIVAA reported that his mount was hanging 'in' throughout the race. The horse was impounded for veterinary

examination but due to its highly fractious behaviour the mouth could not be examined. Trainer Mr. Ashwin S Rao was informed to take appropriate corrective measures before accepting with it again.

Trainer Mr. Aditya K was fined **Rs.5,000/-** for the discrepancy in shoeing in respect of his charge INDIAN PATRIOT in the above race (1st Infringement).

It was reported after the race that SOUND OF CANNON'S (H Rahul) pulled up lame on right fore. Trainer Mr. Aditya K was informed that he must produce a Fitness Certificate from the Club's veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b q SIR CALCULUS.

7thRace: 63. The Sirsi Plate - Div. I (About) 1200 Metres. Horses rated 20 to 45 (10 Runners):

AURELE (R N Darshan) jumped awkwardly inwards and inconvenienced DALI'S GOLD (A Ayaz Khan) on its inside soon after jumping out of the Starting Gates.

Jockey P Kiran Rai, the rider of ANALECT was reprimanded for coming in and inconveniencing IMPULSE (Abhishek Mhatre) on his inside soon after the start.

Jockey Afsar Khan, the rider of SUNWAY LAGOON was fined Rs.1,000/- for travelling wide between the 1100 Metres and 700 Metres for no apparent reason.

It was reported after the race that PERFECT HEART (MadhuSudhan S) pulled up lame on left fore. Trainer Mr. M Bobby was informed that he must produce a Fitness Certificate from the Club's veterinary Officer before accepting with it again
