(Race No. 48 - 54)

Track Condition	: Good

1st Race. 48: The Evita Plate, Div II - (About) 1400 Metres. Horses rated 00 to 25. (10 Runners):

Trainer Mr. Dhyan Subbaiah was fined a sum of **Rs.10,000/-** for having entered his charge, SEDUCTIVE to run in the above Race when it was under Veterinary Treatment.

V CAVIAR (S.G.Prasad) dropped the rider and bolted, on the way to the Starting Gates. Under the circumstances, it was permitted to be **withdrawn** before coming under Starter's Orders.

GOLDEN BEAST (Bharat Mal) dropped the rider and bolted, on the way to the starting gates. Under the circumstances, it was permitted to be **withdrawn** before coming under Starter's Orders.

EXEMPLARY BLUES (Shankar Lal.H) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. G.T. Surrender was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey Ankit Pal, the rider of KING CARLOS was fined **Rs.2,000/-** for coming 'in' and tightening the horses on his inside, viz., LEV RON (Vishal), HIGHER LOVE (H Rahul) and ARMAMENT (Abhishek Mhatre) approaching the 1100 Metres.

Jockey Prabhu Kumar M, the rider of ROYAL TAPESTRY was reprimanded for shifting 'in' and inconveniencing ALLURING BEAUTY (Koshi Kumar) on his inside passing the 900 Metres.

Jockey S. Mubarak, the rider of SALT N PEPPER was reprimanded for shifting 'in' and inconveniencing ARMAMENT (Abhishek Mhatre) on his inside passing the 450 Metres.

Jockey A. Ayaz Khan, the rider of BROCSTON was questioned by the Stipendiary Stewards in the presence of Trainer Mr. C. D. Monnappa for riding in an inept manner. The Trainer, Mr. C D Monnappa stated that his rider, i.e., Jockey A Ayaz Khan had ridden his charge, BROCSTON, in a very feeble manner in the Straight. After repeatedly viewing all the angles of the CCTV footage of the race in question and hearing the explanations tendered by Jockey A. Ayaz Khan, the Stipendiary Stewards strongly felt that Jockey A. Ayaz Khan needs to improve his riding skills. Thereafter, the Stipendiary Stewards decided to inform Jockey A. Ayaz Khan not to accept any rides in Races with immediate effect till the end of the Mysore Summer Races 2026. The Stipendiary Stewards further directed him to rectify all deficiencies

in his riding skills during this period and make every effort to improve the same and thereafter, he shall be required to participate and successfully ride in **Two Mock Races** to the satisfaction of the Stipendiary Stewards before being considered for the grant of permission to accept rides in future. The Stipendiary Stewards noted the explanations tendered by Trainer Mr. C. D. Monnappa for future reference.

2nd Race. 49: The Harangi Dam Plate - (About) 1600 Metres. Horses rated 20 to 45,5years old and over (12 Runners):

COIN EMPRESS (S.G.Prasad) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Feroz M Khan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey Vishal, the rider of NATURAL QUEEN was reprimanded for shifting out and inconveniencing ALPHA DOMINO (C.A.Brisson) on his outside at the start.

Jockey Arvind Kumar. N, the rider of CAROLINA SPRINGS reported that his mount was not galloping fluently throughout the race. The horse was subjected to veterinary examination. On examination, it was found to have sustained a large bruise on left chest wall behind girth.

Jockey Anil Baandaal, the rider of ROCK MY HEART was reprimanded for dropping hands before passing the winning post.

Jockey B.Darshan Anthony, the rider of COORG GENERAL was reprimanded for dropping hands before passing the winning post.

3rd Race. 50: The Evita Plate, Div I - (About) 1400 Metres. Horses rated 00 to 25 (11 Runners):

WOMAN AT WAR (S.S.Khadri) was extremely fractious and refused to be stalled. Under the circumstances, it was permitted to be withdrawn before coming under Starter's Order. In view of its unruly behaviour, Trainer Mr. Himanshu was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey Vinod Shinde, the rider of STRIKING VIKING was fined **Rs.1,000/-** for shifting 'in' and tightening the horses on his inside viz; KALLANIA (A.R.Pradeep) and STARLIGHT WHISPER (Lave Kumar) approaching 1300 Metres.

Jockey Siddaraju.P, the rider of MOONLIGHT SPEED was reprimanded for shifting out and inconveniencing ABNEGATOR (H.Rahul) on his outside approaching 1100 Metres.

It was observed that PERFECT HEART (Koshi Kumar) accidentally brushed the running rails between the 1100 Metres and the 1000 Metres.

Jockey Ankit Pal, the rider of PURPLE MARTINI was fined **Rs.3,000/-** for repeatedly checking his mount from the start till about 900 Metres for no apparent reason.

Jockey Abhishek Mhatre, the rider of GOLDEN SABRE was fined **Rs.1,000/-** for coming 'in' and tightening PERFECT HEART (Koshi Kumar) on his inside approaching 700 Metres.

Jockey Lave Kumar, the rider of STARLIGHT WHISPER was reprimanded for travelling wide rounding the final bend till about the last 100 Metres of the Race, for no apparent reason.

Jockey Anil Baandaal, the rider of COOL WINTER was reprimanded for riding an indifferent race.

STRIKING VIKING (Vinod Shinde) sustained small injury on right fore pastern.

4th Race. 51: The Talakaveri Plate, Div II - (About) 1200 Metres. Horses rated 20 to 45. (11 Runners):

Permission was granted to trainer Mr. Gnanashekar A to **withdraw** MARTINO (R.Vaibhav) on veterinary grounds as it was suffering from pain on left fore cannon bone. He was informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

Jockey Lave Kumar, the rider of DALI'S GOLD reported that his saddle shifted back in the final 100 Metres. After due examination of the equipment, Trainer Mr. Somashekar K was fined **Rs.3,000/-** for faulty saddling of his charge.

It was reported after the race that DALI'S GOLD (Lave Kumar) returned lame on right fore. Trainer Mr. Somashekar K was informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

Jockey C.A. Brisson, the rider of BLAZING STAR was reprimanded for shifting out and inconveniencing O MANCHALI (Koshi Kumar) on his outside soon after the start.

Jockey Bharat Mal, the rider of CLEAN SLATE was fined **Rs.2,000/-** for failing to wear his goggles during the race.

Jockey K.Sai Kiran, the rider of D ROMAN POWER was fined **Rs.2,000/-** for travelling wide from the 1000 Metres till about the 500 Metres for no apparent reason.

It was observed that CALCULUS (Sah Farid Ansari) drifted out under pressure in the final 200 Metres. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Ramanathan R was informed to take appropriate corrective measures before accepting with it again.

VIJAYA STAR (S. Mubarak) ran detached from the field. Trainer Mr. Bobby M was informed to ensure better performance of his charge in future.

Trainer Mr. Suresh.B was questioned regarding the relatively improved performance of his charge SINATRA (Faiz), the winner of the above race as compared to its previous run in Race No. 35 i.e., The Kapila Plate, Div – II (about) 1200 Metres, horses rated 20 to 45, 5 years old and over run on 24th June, 2026 wherein it ran unplaced. After due enquiry and not being satisfied with the explanations tendered by Trainer Mr. Suresh B, he was fined a sum of **Rs.10,000/-** for the unsatisfactory explanations tendered by him.

O MANCHALI (Koshi Kumar) sustained bleeding injury on right fore coronet.

Routine sample was taken for analysis from the winner b g SINATRA.

5th Race. 52: The Mysore Colts Trial Stakes 2026 - (About) 1400 Metres. For 3 year old Indian Colts and Geldings (Foaled in 2023) (Terms) (6 Runners):

Jockey B. Nikhil, the rider of PILOT OFFICER was fined **Rs.3,000/-** for shifting out and bumping EDISON (Vivek.G) on his outside soon after the Start.

Jockey A.Ashhad Asbar, the rider of STORMRIDER was fined **Rs.3,000/-** for shifting 'in' and bumping EDISON (Vivek.G) on his inside soon after the Start.

Jockey Koshi Kumar, the rider of AIR BENDER reported that his goggles came off soon after jumping out of the Starting Gates.

Jockey Vivek. G, the rider of EDISON reported that his mount was hanging out after entering the straight. Trainer Mr. M. Eshwer was informed to take appropriate corrective measures before accepting with it again.

Jockey Koshi Kumar, the rider of AIR BENDER reported that his mount was hanging out after entering the straight. Trainer Mr. Arvind V was informed to take appropriate corrective measures before accepting with it again.

Routine sample was taken for analysis from the winner b c BULLETPROOF.

6th Race. 53: The Talakaveri Plate, Div I - (About) 1200 Metres. Horses rated 20 to 45. (12 Runners):

LIKE MY CHILD (S.G.Prasad) reared up as the gates opened and lost many lengths at the start. In view of its behaviour, Trainer Mr. Dhyan Subbaiah K was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

HABIBTI (A. Ashhad Asbar) jumped awkwardly inwards and bumped SPARKLING NIGHT (Ankit Pal), on its inside at the start.

Jockey Y.S. Srinath, the rider of MIRACULOUS GIRL was reprimanded for shifting 'in' and inconveniencing SPARKLING NIGHT (Ankit Pal) on his inside approaching the 1000 Metres.

Jockey Vishwa V, the rider of MYSTIC CHARM was fined **Rs.1,000/-** for shifting 'in' and tightening WORDS WORTH (B.Darshan Anthony) on his inside passing the 1100 Metres.

Jockey Faiz, the rider of ADENA reported that his mount was hanging out throughout the race. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr. Feroz M Khan was informed to take appropriate corrective measures before accepting with it again.

Jockey Lave Kumar, the rider of GOLDEN BIRD reported that his mount was hanging out after entering the straight. Trainer Mr. Helleal Moses R was informed to take appropriate corrective measures before accepting with it again.

Jockey Koshi Kumar, the rider of MR KARNATAKA was fined **Rs.3,000/-** for the excessive use of whip on his mount during the race **(1st infringement)**.

Jockey Ankit Pal, the rider of SPARKLING NIGHT was reprimanded for dropping hands before passing the Winning Post.

Jockey A. Ashhad Asbar, the rider of HABIBTI was reprimanded for riding an indifferent race.

An enquiry is being held into the running and riding of MYSTIC CHARM, trained by Mr. K.S. Mandanna and ridden by Jockey Vishwa.V in the above race.

LIKE MY CHILD (S.G.Prasad) sustained gum injury.

Routine sample was taken for analysis from the winner b f SELMA.

7th Race. 54: The Red Rufus Plate - (About) 1400 Metres. Horses rated 40 to 65 (12 Runners):

Jockey Arvind Kumar.N, the rider of RED FALCON reported that he lost his left stirrup soon after jumping out of the starting gates, which he regained within a few strides.

Jockey Ankit Pal, the rider of NATURAL TORNADO was fined **Rs.5,000/-** for not making sufficient effort on his mount during the race.

Permission was granted to trainer Mr. Ranjeet Shinde to deputize on behalf of trainer Mr.S.S. Attaollahi who was unable to attend the races.
