RACING INCIDENTS

(Race No. 64 - 69)

Weather	: Cloudy
Track Condition	: Good Going
Penetrometer reading	: 2.7 Cms.
Positioning of Railings	: Railings are positioned at an average Width of 3.5 Metres from the 1600 Metres to the Winning Post from its original position.

1st Race: 64. The Mysore Zoo Plate (About) 1600 Metres. Horses rated 40 to 65, 6 years old and over (7 Runners):

TERMINATOR (J Paswan) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Vishal Yadav was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

It was observed that D ROMAN POWER (V R Jagadeesh) could not get a clear run in the final stages of the race due to a closely packed field.

Jockey Vivek G, the rider of NATURAL SPEED reported that his mount was hanging out after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Vinesh V Naik was informed to take appropriate corrective measures before accepting with it again.

Jockey Vivek G, the rider of NATURAL SPEED was fined **Rs.3,000/-** for the excessive whip on his mount during the race (**1st Infringement**).

2nd Race: 65. The Vijayawada Plate(About) 1200 Metres. Horses rated 20 to 45, 6 years old and over (8 Runners):

WIND POWER (Shreyas Singh) took a fly jump and lost few lengths at the start. In view of its behaviour, Trainer Mr. G Srinivas Babu was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

D GOLDEN CUP (Ajeet Kumar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Vishal Yadav was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey Ajeet Kumar, the rider of D GOLDEN CUP was reprimanded for riding an indifferent race.

It was reported after the race that SPIRITUAL FORCE (Abhishek Mhatre) burst its blood vessels during the race. Trainer Mr. Helleal Moses R was informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

D GOLDEN CUP (Ajeet Kumar) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b m RED HILLS.

3rd Race: 66. The GerusoppaPlate (About) 1600 Metres. Horses rated 00 to 25 (11 Runners):

ANTINORI (H Rahul) planted, lost many lengths at the start and ran detached thereafter. In view of its behaviour, Trainer Mr. Vishal Yadav was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

It was observed that COORG GENERAL (Rahil Akhtar) drifted out after rounding the final bend and went onto the outer sand track in the final 200 Metres of the race. In view of its behaviour, Trainer Mr. Aditya K was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey Anil Baandal, the rider of GAME BOY was fined **Rs.1,000/-** for shifting in and causing interference to ANKUSH (A Ayaz Khan) on his inside passing the 500 Metres.

Jockey P Sai Kumar, the rider of ECO SYSTEM was reprimanded for not maintaining a straight course in the final 300 Metres of the race.

Jockey Faiz, the rider of FREE SPIRITED reported that his mount grabbed the bit on one side and was trying to run out in the straight. The horse was impounded for veterinary examination and the examination of the mouth revealed old ulcer at left oral commissure.

Jockey Abhishek Mhatre, the rider of WARRIOR WOMAN reported that his mount was hanging out throughout the race. The horse was impounded for veterinary examination and the examination of the mouth revealed sharp molars, Trainer Mr. G Srinivas Babu was fined **Rs.3,000/-** for his negligence.

ANKUSH (A Ayaz Khan) was impounded for veterinary examination but no abnormality was reported.

COORG GENERAL (Rahil Akhtar) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g ECO SYSTEM.

4th Race: 67. The M Govindappa Memorial Trophy (About) 1200 Metres. Horses rated 60 and above (11 Runners):

Permission was granted to Trainer Mr. Srinivas Babu G to **withdraw** his charge, SEGERA from the above race.

Jockey M Prabhakaran, the rider of CONTRIBUTOR was fined **Rs.1,000/-** for coming in sharply and causing interference to the horses on his inside viz. RIVER OF GOLD (S A Amit), THE FLYING FEET (P Sai Kumar) and MANDOLIN (Prabhu Kumar M) on his inside approaching the 1100 Metres.

It was observed that approaching the 1000 Metres in a closely packed field when the horses were in a fierce gallop RIVER OF GOLD (S A Amit) accidentally clipped the heels of the front runner SILVER SPRING (Aman) and fell down dislodging its rider. As a result BRAVE TROOPER (Abhishek Mhatre) which was running directly behind the latter collided with the prostrated horse, RIVER OF GOLD and fell down thereby dislodging its rider. Thereafter ABSOLUTE CHALLENGER (R Shiva Kumar) collided with prostrated horse BRAVE TROOPER and fell down dislodging its rider. As no fault could be attributed to any rider, no action was taken besides noting the incident.

It was reported after the race that SMART CADILLAC (Rajesh K) pulled up lame on right fore. Trainer Mr. Pratap Kamath R was informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

SILVER SPRING (Aman) sustained clipped injury on right hind back of pastern.

RIVER OF GOLD (S A Amit) returned bleeding from mouth.

BRAVE TROOPER (Abhishek Mhatre) sustained gum injury.

5th Race: 68. The Sankranthi Plate (About) 1400 Metres. Horses rated 40 to 65 (10 Runners):

Jockey S K Paswan, the rider of DIVINE RAY reported that his mount was not galloping fluently throughout the race and completely stopped galloping after passing the final 200 Metres. The horse was impounded for veterinary examination but no abnormality was reported however Trainer Mr. P Ruben was informed to ensure better performance of his charge in future.

Jockey Koshi Kumar, the rider of NATURAL TORNADO was fined **Rs.3,000/-** for not sufficiently persevering with his mount in the closing stages of the race.

Jockey H Rahul, the rider of FLYING FALCON reported that his mount was trying to run out after entering the straight. The horse was impounded for veterinary examination and the examination of the mouth revealed sharp molars. Trainer Mr. Bipin V Salvi was fined **Rs.3,000/-** for his negligence [**1st Infringement**].

Jockey Vivek G, the rider of NATURAL GOLD was fined **Rs.5,000/-** for the excessive whip on his mount during the race (**2nd Infringement**).

It was reported after the race that SILVER DAYS AGAIN (Madhu Sudhan S) pulled up lame on right fore. Trainer Mr. Bobby M was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch g NATURAL GOLD.

6th Race: 69. The Formal Invitation Plate (About) 1400 Metres. Horses rated 20 to 45, No Whip (13 Runners):

As Jockey R Shiva Kumar, the declared rider of FASHIONISTA was certified medically unfit to ride after his fall in the 5th race and as no suitable substitute rider was available. Permission was granted to Trainer Mr. Ruben P to **withdraw** FASHIONISTA from the above race.

Jockey Prabhu Kumar M replaced the indisposed Jockey Madhu Sudhan S on THE WHISPERING.

It was observed that SAPIENT (L Alex Rozario) accidentally brushed the running rails approaching the 1000 Metres.

It was observed that TENDRILS OF POWER (Afsar Khan) ran detached after passing the 400 Metres. Trainer Mr. Ruben P was advised to ensure better performance of his charge in future.

It was reported after the race that THE WHISPERING (Prabhu Kumar M) pulled up lame on right hind. Trainer Mr. Ganesh J was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

NOBLE PURSUIT (A Ayaz Khan) sustained clipped injury on right hind outer bulb of heel.

INEFFABLE (Siddaraju P) sustained gum injury.

Routine Sample was taken for analysis from the winner dk b h ONE DIAMOND.

RACE NO. 53: THE NANDIDURGA PLATE (ABOUT) 1100 METRES. HORSES RATED 20 TO 45, 6 YEARS OLD AND OVER, AT THE TIME OF STARTING:

The Stipendiary Stewards questioned Trainer, Mr. G T Surender, as to the reversal of form and the resultant improved performance of WORDLY WISE, ridden by Jockey J Paswan, the winner of the above race as compared to its previous run in Race No. 28, i.e The Crown Treasure Plate (About) 1400 Metres,

for horses rated 40 to 65, 5 years old and over run on Fourth Day, Wednesday, 4th December, 2024 when ridden by Jockey S Imran it ran unplaced. After due enquiry and not being satisfied with the explanations tendered by Trainer Mr. G T Surrender the Stipendiary Stewards decided as follows;

a) To fine Trainer Mr. G T Surrender a sum of **Rs.10,000/- (Rupees Ten Thousand only)** for the reversal of form and the resultant improved performance of his charge WORDLY WISE, in the above Race; and

b) Caution him that a repeat of a similar manner of offence by him in future, would entail him being reported to the Stewards for appropriate action.
