RACING INCIDENTS (Race No. 15 - 21)

Weather : Cloudy

Track Condition : Good Going Penetrometer reading : 3.1 Cms.

Positioning of Railings : Railings are positioned from 1600 mtrs.

position.

1st Race: 15. The Kolar Plate (About) 1100 metres. For Maiden India Horses 3 years old only (9 Runners):

N R I VICTORY (Anil Baandal) bolted on its way to the Starting Gate dislodging its rider. Under the circumstances, it was permitted to be **withdrawn** before coming under Starter's Orders.

HIGHLAND DREAM (P Sai Kumar) jumped out awkwardly and bumped SHEROUK (S Antony Raj) on its outside, at the start.

Jockey T Pavan, the rider of FIRE BOLT, was fined **Rs.2,000/-** for shifting `in' and causing interference to CALYPSO KING (R N Darshan), on his outside, which went onto N R I ACE (Arshad Alam) on its outside at the Start.

Jockey P Sai Kumar, the rider of HIGHLAND DREAM, was fined **Rs.2,000/**-for shifting in and causing interference to FERONIA (P Ajeeth Kumar), on his inside, passing the 1000 Metres.

FIRE BOLT (T Pavan) got keen and was about to collide with the front runners and as such was shifted out by its rider, due to which the horse stumbled and dislodged its rider. Thereafter, NOBLE PURSUIT (G Manikandan) travelling directly behind, collided with the fallen horse and went down, dislodging its rider.

At the behest of the Stewards, an enquiry was ordered and held, in particular reference to the above mentioned fall of the horses, viz., FIRE BOLT (T Pavan) and NOBLE PURSUIT (G Manikandan). After due enquiry and

after repeatedly viewing the CCTV replay of the above Race, the Stewards, applying their minds, decided that the fall of the above riders was purely accidental and decided not to alter the Judges Placings of the above Race.

FERONIA (P Ajeeth Kumar) sustained superficial clipped injury on left hind outer cannon.

2nd Race: 16. The Kollegal Plate - Div. II (About) 1200 metres. Horses rated 00 to 25 (9 Runners):

AMARON TIGRESS (Rahil Akhtar) fell over while being saddled at the Saddling Enclosure and sustained injuries on both hock and left hind fetlock bleeding injury in the Saddling Yard; Under the circumstances, it was permitted to be <u>withdrawn</u> on veterinary grounds before coming under Starter's Orders; Trainer Mr. Surender G T was informed that he must produce a <u>Fitness Certificate</u> from the Club's Veterinary Officer before accepting with it again.

SQUANTO (Angad) was impounded for veterinary examination but no abnormality was reported.

An enquiry is being held into the running and riding of SQUANTO, trained by MR. Vikram Appachu and ridden by Jockey Angad, in the above Race.

Routine Sample was taken for analysis from the winner ch m D GOLDEN CUP

3rd Race: 17. The Prince Regent Plate - Div. II (About) 1200 metres. Horses rated 20 to 45 (9 Runners):

CODE OF HONOR (M Prabhakaran) was examined at the Gates and observed to be trotting lame on left fore; Under the circumstances, it was permitted to be **withdrawn** on veterinary grounds before coming under Starter's Orders; Trainer Mr. Bobby M was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

MYRAA'S PRINCE (R Manish) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Joseph B Awale was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate Practice Day.

Jockey R Shiva Kumar, the rider of ANKUSH reported that due to the fractious behavior of his mount, he accidentally dropped his whip at the Gates, just as the Start was given.

NRI TOUCH (Arshan Alam) sustained bruises in both hind inter bulbar region.

4th Race: 18. The Kollegal Plate - Div. I (About) 1200 metres. Horses rated 00 to 25 (10 Runners):

ONLY A STAR (Dhanu Singh Deora) accidentally stumbled passing the 900 metres.

Jockey P Kiran Rai, the rider of NISHK was fined **Rs.5,000/-** for riding an indifferent race.

REAP THE BOUNTY (Anil Baandal) was impounded for veterinary examination and was reported to have sustained gum injury.

Routine Sample was taken for analysis from the winner, b f NATURAL HUNTER.

5th Race: 19. The Dr. N M Srinivas Memorial Cup (About) 1400 metres. Horses rated 40 to 65, 5 years old and over (13 Runners):

As Jockey T Pavan, the declared rider of TRUST BOND, was certified medically unfit to ride. permission was granted to Trainer Mr. Pratap Kamath M to substitute Jockey M Prabhu Kumar to ride TRUST BOND in place of the declared rider.

Jockey Anil Baandal, the rider of EXUBERANCE was fined **Rs.5,000/-** for riding an indifferent Race.

It was reported after the Race that TRUST BOND (M Prabhu Kumar) pulled up lame on left fore. Trainer Mr. Pratap Kamath M was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

MYSTIC DIVINE (P Sai Kumar) sustained small injury inside right hock.

Surprise Sample was taken for analysis from ch h EXUBERANCE.

6th Race: 20. The Prince Regent Plate - Div. I (About) 1200 metres. Horses rated 20 to 45 (10 Runners):

COPPER SUNRISE (M Rajesh Kumar) was observed to be trotting lame on right hind due to muscular sprain. Under the circumstances, it was permitted to be **withdrawn** on veterinary grounds. Trainer Mr. Ramesh S was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

STAR JEWEL (Prabhu Kumar M) reared up as the gates opened, thereby losing some ground, at the Start.

SIRA (Shivam), drifted 'out' alarmingly after entering the straight despite the best efforts of the rider, inconvenienced INFINITEPOSIBILITY (P Kiran Rai) on its outside between 550 metres to 250 metres and thereafter finished the Race on the outer sand track. The horse was impounded for veterinary examination and was reported to have a loose cap. Trainer Mr. Eshwer M was informed to take appropriate remidial measures before accepting with it again.

Routine Sample was taken for analysis from the winner, b f EMERALD QUEEN.

7th Race: 21. The Balamuri Plate (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (15 Runners):

PROSPEROUS PRINCE (Arshad Alam) shifted its head to the right as the Gates opened thereby losing few lengths at the Start.

FLAMINGO DANCER (P Ajeeth Kumar) sustained large clipped injury on right hind cannon region.
