#### **RACING INCIDENTS**

**(Race No. 77 - 82)**

**Weather** : Clear  
**Track Condition** : Good Going  
**Penetrometer reading** : 2.7Cms.  
**Positioning of Railings** : Railings are fixed at an average width of 5.5 Metres from the 1600 Metres to the Winning Post from its Original Position.

#### **1<sup>st</sup> Race: 77. The Bababudan Giri Plate (About) 1100 Metres. For Indian Horses 3 years old only (5 Runners):**

It was observed that PARK WEST (S Antony Raj) veered out badly after passing the 300 Metres despite the best efforts of the Jockey to keep it on an even course and eventually finished the race on the outer sand track. The horse was impounded for veterinary examination but no abnormality was reported. However, in view of its behaviour, Trainer Mr. M Eshwer was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

**An enquiry is being held into the running and riding of PARK WEST, trained by M Eshwer and ridden by Jockey S Antony Raj in the above race.**

Surprise Sample was taken from analysis from b f PARK WEST.

#### **2<sup>nd</sup> Race: 78. The Hampi Plate (About) 2000 Metres. Horses rated 20 to 45 (4 Runners):**

Permission was granted to Trainer Mr. Bipin V Salvi to **withdraw** D LORD on veterinary grounds as it was suffering from sore back. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

Jockey Siddaraju P, the rider of AURELE was fined **Rs.3,000/-** for not exercising sufficient control over his mount thereby allowing his mount to drift out after rounding the final bend.

Jockey Vinod Shinde, the rider of SAPIENT reported that his saddle shifted front after entering the straight. After due examination of the equipment which was found to be in serviceable condition, Trainer Mr. J S Pillay was fined **Rs.3,000/-** for faulty saddling.

It was reported after the race that TENDU (Shamaz Shareef) pulled up lame on left hind and sustained injury on right hind cannon. Trainer Mr. M Eshwer was

informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken from analysis from the winner b f SAPIENT.

**3<sup>rd</sup> Race: 79. The Vesuvius Plate (About) 1200 Metres. Horses rated 00 to 25, 6 years old and over (12 Runners):**

As Jockey M J Gautam Raj Urs, the rider of CZAREVITCH was certified medically unfit to ride, permission was granted to Trainer Mr. Ranjeet Shinde to substitute Jockey H Rahul to ride CZAREVITCH in place of the declared rider.

COUNTRY'S MAJOR (A Ayaz Khan) was extremely fractious and refused to be stalled. Under the circumstance it was permitted to be **withdrawn** before coming under Starter's Orders.

BRAVE GIRL (Akash Agarwal) did not raise a fluent gallop after jumping out and ran detached from the field. In view of its behaviour, Trainer Mr. Ashwin S Rao was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey Afsar Khan, the rider of THE ANGEL POWER was fined **Rs.3,000/-** for not making sufficient effort to improve his position, round the bend and thereafter, for not making effort to extricate himself from the pocket along the Railings, after entering the Straight.

**4<sup>th</sup> Race: 80. The Andolana Trophy (About) 1400 Metres. Horses rated 60 and above (7 Runners):**

GOLD KITE (Siddaraju P) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Aditya K was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

HAVELOCK CRUISE (N Tauseef Ahmed) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Surender G T was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey M Prabhakar, the rider of CONTRIBUTOR was fined **Rs.1,000/-** for not maintaining a straight course between the 400 Metres and 200 Metres thereby allowing his mount to drift out in the straight.

Jockey H Rahul, the rider of ABSOLUTE CHALLENGER reported that his mount was not galloping fluently throughout the race and he had to ease up his mount in the final 250 Metres of the race. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Vishal Yadav was informed to take appropriate corrective measures and ensure better performance of his charge in future.

Surprise Sample was taken from analysis from ch g EXUBERANCE.

**5<sup>th</sup> Race: 81. The Mangalore Plate (About) 1100 Metres. Horses rated 20 to 45, 6 years old and over (8 Runners):**

EAGLE BUFF (Akash Agarwal) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Ashwin Rao S was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

DALHOUSIE (Siddaraju P) threw its head up and did not raise a fluent gallop for the first 100 Metres and lost many lengths. In view of its behaviour, Trainer Mr. Aditya K was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey Vinod Shinde, the rider of D GOLDEN CUP reported that his mount was hanging out after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported.

It was reported after the race that PRICELESS BEAUTY (Anil Baandal) burst its blood vessels and pulled up lame on right fore. Trainer Mr. Ranjeet Shinde was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that DALHOUSIE (Siddaraju P) pulled up lame on right fore. Trainer Mr. K Aditya was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

ELEVADO (MadhuSudhan S) sustained gum injury.

**6<sup>th</sup> Race: 82. The Cochin Plate (About) 1600 Metres. Horses rated 40 to 65 (10 Runners):**

As Jockey L Alex Rozario, the declared rider of POLAR WIND was certified medically unfit to ride, permission was granted to Trainer Mr. C D Monappa to substitute Jockey Koshi Kumar to ride POLAR WIND in place of the declared rider.

TAREK (M Prabhakaran) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. M Bobby was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey Rajesh K the rider of SERDAR, was reprimanded for shifting out and inconveniencing ABSOLUTE CONQUERER (A Ayaz Khan) on his outside, between the 200 Metres and 100 Metres.

THALAIVAA (Akash Agarwal) was impounded for veterinary examination but no abnormality was reported.

**An enquiry is being held into the severe interference cause by Jockey Akash Agarwal, the rider of THALAIVAA to the horses on his inside viz. AMAZING DESIRE (H Rahul), SIR CALCULUS (Vinod Shinde) and POLAR WIND (Koshi Kumar) approaching the 700 Metres and for coming in and**

**causing interference to MAGIC CIRCLE (Anil Baandal) on his inside along the rails passing the 350 Metres.**

SERDAR (K Rajesh) was impounded for veterinary examination but no abnormality was reported.

#### **RACE NO. 56: THE TAJ MAHAL PLATE (ABOUT) 1600 METRES. HORSES RATED 20 TO 45:**

In deference to his request, the Board of Appeal of the Mysore Race Club Limited has **decided to stay** the operation of punishment meted out to Trainer Mr Ramesh S by the Stewards of the Mysore Race Club Limited at their meeting on 22<sup>nd</sup> January 2025 wherein the Stewards had decided to declare him a disqualified person from **1<sup>st</sup> February, 2025 to 31<sup>st</sup> January, 2027** (both days inclusive) for contravention of Rule No. 114 (b) (i) [Negligence in the discharge of his duties as a Licensed Professional] read with Rule No. 202 (i) [Improper Practice and Dishonourable Action], 202 (vii) [tendering misleading evidence] and 202 (xiii) of the Mysore Race Club Ltd., Rules of Racing, read with Clause 3 of the Calendar Notification under the heading TRAINERS LICENSES, pertaining to the reversal of form and the resultant improved performance of his charge WHAT IS THIS, in the above Race, until his appeal is finally heard and disposed off by the Board of Appeal.

In deference to his request, the Board of Appeal of the Mysore Race Club Limited has **decided to stay** the operation of punishment meted out to Trainer Mr Girinath C by the Stewards of the Mysore Race Club Limited at their meeting on 21<sup>st</sup> January 2025 wherein the Stewards had decided to declare him a disqualified person from **1<sup>st</sup> February, 2025 to 31<sup>st</sup> January, 2027** (both days inclusive) for contravention of Rule No. 114 (b) (i) [Negligence in the discharge of his duties as a Licensed Professional] read with Rule No. 202 (i) [Improper Practice and Dishonourable Action, (lying to the Stipendiary Stewards)], Rule No. 202 (vii) [Misleading evidence tendered during the enquiry by the Stipendiary Stewards] and Rule No. 202 (xiii) of the Mysore Race Club Rules of Racing, read with Clause 3 of the Calendar Notification under the heading "TRAINERS

LICENSES", pertaining to his charge, ANALECT, in the above race, until his appeal is finally heard and disposed off by the Board of Appeal.
