#### **1<sup>st</sup> Race: 107. The Delhi Race Club Trophy – Div. II (About) 1200 metres.** **Horses rated 00 to 25 confined to Mysore based horses (12 Runners):**

Jockey Anil Baandal, the rider of RUBY WOO was reprimanded for shifting `in' and inconveniencing CALIFORNIA GOLD (A S Peter), on his inside, at the start.

Jockey Shamar Shareef, the rider of CODE OF HONOUR reported that his mount was hanging `in' after entering the straight; The horse was impounded for veterinary examination, but no abnormality was reported; However, Trainer Mr. Bobby M was informed to take appropriate corrective measures before accepting with it again.

Jockey Vivek G, the rider of RAPTOR, reported that his mount was hanging "out", rounding the bend and after entering the straight. The horse was impounded for veterinary examination, but due to its extremely fractious behaviour, it could not be examined; However, Trainer Mr. C D Monnappa was informed to take appropriate corrective measures before accepting with it again.

IRONIC HUMOUR (B Harish) sustained bruises on both hind plantar fetlock.

Routine Sample was taken for analysis from the winner, ch m FIFTY GRAND.

#### **2<sup>nd</sup> Race: 108. The Delhi Race Club Trophy – Div. I (About) 1200 Metres.** **Horses rated 00 to 25 confined to Mysore based horses (11 Runners):**

Permission was granted to Trainer Mr. Bipin V Salvi to **withdraw** GAMEBOY on veterinary grounds as it sustained acute infection of capped elbow on right fore; He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

RICH STRIKE (L Alex Rozario) reared up as the gates opened and lost few lengths at the start; In view of its behaviour, Trainer Mr. Ashwin Rao S was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate Practice Day.

MIGHTY PRINCE (Abhishek Mhatre) accidentally knuckled passing the 1100 Metres.

Jockey Inayat, the rider of SPARKLING NIGHT, was fined **Rs.3,000/-** for shifting 'out' and causing interference to VARDaan (Md. Imran Ashraf) and MYSTICAL MERLIN (T Pavan), on his outside, at the start.

**3<sup>rd</sup> Race: 109. The Royal Calcutta Turf Club Trophy (About) 1100 Metres. Horses rated 20 to 45, 5 years old and over (12 Runners):**

Jockey M Naveen, the rider of OSIRIS, was fined **Rs.3,000/-** for shifting 'in' and causing interference to STONE HOUSE (P Kiran Rai), on his inside, soon after the start.

Jockey M Rajesh Kumar, the rider of COPPER SUNRISE, was fined a total sum of **Rs.5,000/-** for shifting in and causing interference to ULTIMATE STRIKER (Akshay Kumar) on his inside and thereafter, for shifting out and causing interference to ULTIMATE STRIKER (Akshay Kumar), on his outside, between the 850 Metres and the 550 Metres and again, for shifting out and causing interference to WIND POWER (Abyn Merchant) on his outside, approaching the 400 Metres.

Jockey Abyn Merchant, the rider of WIND POWER, was fined a total sum of **Rs.5,000/-** for not making sufficient effort to improve his position, rounding the bend and thereafter, for not infusing adequate vigour to ride out his mount, in the closing stages of the Race.

Jockey Akshay Kumar, the rider of ULTIMATE STRIKER reported that his mount was not galloping fluently throughout the Race and he was first interfered by COPPER SUNRISE (M Rajesh Kumar) on his outside passing the 800 Metres and thereafter he was taken 'out' passing the 600 Metres. The horse was impounded for veterinary examination, but no abnormality was reported; However, Trainer Mr. Loknath V was informed to ensure better performance of his charge in future.

READY PLAYER ONE (Brahmesh S) ran detached from the field throughout the Race. Trainer Mr. Aditya K was informed to ensure better performance of his charge in future.

Surprise Sample was taken for analysis from the winner, b g OSIRIS.

**4<sup>th</sup> Race: 110. The Madras Race Club Trophy (About) 1400 Metres. Horses rated 20 to 45 (14 Runners):**

Permission was granted to Trainer Mr. Faraz Arshad to **withdraw** FLYING BRAVE (Shamaz Shareef) on veterinary grounds as it cellulitis of the right fore cannon. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

BURST OF BLAZE (B Nayak) planted and lost many lengths; In view of its behaviour, Trainer Mr. C D Monnappa (deputizing on behalf of Trainer Mr. Pradeep Annaiah K) was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the race track.

DALHOUSIE (Tousif Khan) planted and lost many lengths at the Start. In view of its behaviour, Trainer Mr. Aditya K was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the race track.

SOLID POWER (S Hussain) did not raise a fluent gallop after jump out thereby losing many lengths at the Start and thereafter ran detached from the field; In view of its behaviour, Trainer Mr. Rajendra Singh M was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the race track.

Routine Sample was taken for analysis from the winner, b f IMMORTAL BEAUTY.

**5<sup>th</sup> Race: 111. The Bangalore Turf Club Trophy (About) 1200 Metres. Horses rated 80 and above (5 Runners):**

Compulsory Sample was taken for analysis from ch m ASHTAR.

**6<sup>th</sup> Race: 112. The 1xBet Mysore Derby 2023 (Grade I) (About) 2000 Metres. For 3 year old Indian horses (Foaled in 2020) (9 Runners):**

Jockey Vinod Shinde, the rider of FEARLESS JOEY was fined **Rs.3,000/-** for shifting `in' and causing interference to ELOQUENT (C Umesh), STRAVINSKY (L Alex Rozario), RULING DYNASTY (Akshay Kumar) and MAGNUS (Y S Srinath), on his inside, at the Start.

Jockey Vivek G, the rider of FAST PACE was fined a total sum of **Rs. 3,000/-** for not maintaining a straight course at the Start and thereafter for shifting `in' and causing interference to TOUCH OF GREY (Suraj Narredu) on his inside approaching 1900 Metres due to which, the latter horse stumbled.

Jockey Suraj Narredu, the rider of TOUCH OF GREY was fined a sum of **Rs.10,000/-** for shifting `in' and causing very severe interference to RIVER OF GOLD (Saqlain S) on his inside, which in turn, went onto FAST PACE (Vivek G), along the rails, due to which the latter horse, which was galloping along the rails, got boxed in, passing the 450 Metres.

ELOQUENT (C Umesh) sustained cut injury on right fore outer cannon.

**7<sup>th</sup> Race: 113. The Royal Western India Turf Club Ltd Trophy (About) 1200 Metres. Horses rated 40 to 65, 5 years old and over (11 Runners):**

Permission was granted to Trainer Mr. Pradeep Annaiah K to **withdraw** HIGH OPINION (Hindu Singh) on veterinary grounds as it was off feed. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

AIR DISPLAY (Siddaraju P) was slowly away and lost few lengths at the start; In view of its behaviour, Trainer Mr. Inayathulla S was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate Practice Day.

DEFINING POWER (M Rajesh Kumar) jumped out awkwardly at the Start.

Jockey A K Aniket, the rider of SPIRITUAL FORCE, was fined **Rs.3,000/-** for the excessive use of the whip on his mount during the Race **[First Infringement]**.

Routine Sample was taken for analysis from the winner, dk b g THE KING N I.

**8<sup>th</sup> Race: 114. The Hyderabad Race Club Trophy (About) 1400 metres. Horses rated 40 to 65 (15 Runners):**

PERFECTIMAGINATION (Angad) planted and lost many lengths at the Start; In view of its behaviour, Trainer Mr. P C Tejaswi was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the race track.

Jockey Vinod Shinde, the rider of MOONLIGHT QUEENT, reported that the saddle shifted back, passing the 400 Metres. After due examination of the equipment, Trainer Mr. Rakesh was fined **Rs.3,000/-** for faulty saddling.

Jockey Noorulla, the rider of MOUNTAIN LION was fined **Rs.3,000/-** for improper use of whip, during the above Race.

Jockey Noorulla, the rider of MOUNTAIN LION was reprimanded for riding an indifferent race.

Jockey J Paswan, the rider of IBRAHIMOVIC was reprimanded for riding an indifferent race.

**RACE NO. 8: THE VIRIJA PLATE – DIV II, (ABOUT) 1100 METRES, FOR HORSES RATED 00 TO 25, CONFINED TO MYSORE BASED HORSES:**

The Stewards of the Mysore Race Club Ltd., considered the analytical report received from QuantiLab, Mauritius pertaining to the analysis of the urine sample taken from **ch m WAR SONG** (Trained by Mr. Girinath C and Owned by M/s Swiss Stud and Live Stock Pvt. Ltd.) which had shown the presence of the drugs **Phentermine [Class II] and Mephentermine [Class I] – prohibited substances** – the sample of which was taken after the said horse won the above race.

The Stewards noted the following:

The Trainer was informed of this and was given the option of sending the split sample of the urine of the said horse for confirmatory analysis.

The Trainer vide his dated 13<sup>th</sup> October, 2023 had informed the Club that he would like the split sample of the horse to be sent to LGC, New Market, United

Kingdom. Accordingly, the split sample was sent to the said laboratory and the said laboratory confirmed the presence of the drugs **Phentermine [Class II] and Mephentermine [Class I] – prohibited substances**, vide its report dated 1<sup>st</sup> November, 2023, which has also been informed to the Trainer concerned.

Therefore the Stewards decided to disqualify the horse **ch m WAR SONG**, from the above race and revised the order of the placing as under:

The Stewards of the Mysore Race Club Ltd., considered the analytical report received from QuantiLab, pertaining to the analysis of the urine sample taken from **ch m ASHTAR** (owned by Mr. Hooshang Pashotan and trained by Mr. G T Surrender) which had shown the presence of **FLUNIXIN [Class IV] – a Prohibited Substance** – the sample of which was taken after the said horse won the above race.

The Stewards noted the following:

The Trainer was informed of this and was given the option of sending the split sample of the urine of the said horse for confirmatory analysis.

The Trainer vide his letter dated 3<sup>rd</sup> November, 2023 has informed the Club that he did not wish to send the "B" Sample for Confirmatory analysis.

Therefore the Stewards decided to disqualify the horse **ch m ASHTAR**, from the above race and revised the order of the placing as under:
