## NOTICE

### NORMS FOR GRANT OF "B" LICENSE TO TRAINERS UNDER My.R.C. LTD., RULES OF RACING (As amended by the Stewards on 17<sup>th</sup> March, 2025)

The Stewards of the Mysore Race Club Ltd have decided the following norms for the "B" Trainer license under the My.R.C. Ltd Rules of Racing;

1. Trainers who wish to apply for "B" License under My.R.C. Ltd., Rules of Racing should have a valid "A" Trainer's License granted by any of the recognized Turf Authorities of India. The aspiring "A" Licensed trainer/s of other centres shall fill up their applications in the requisite form (available on the Club's website) and submit the same to the Office of the Club. The last date of receiving such applications for grant of a "B" Trainer's license shall be 15<sup>th</sup> April, 2025.

2. i) Allotment of stables shall be in order of priority subject to the availability of stables. They are permitted to bring in horses under the categories as mentioned below:

- a). 3 year olds which have been entered in sweepstakes races;
- b). Horses aged 3 to 6 years with a rating of 26 & above;
- c). Horses aged 7 years with a rating of 40 & above;

ii) These horses which are under the care of "B" License trainers are eligible to participate in the following category races;

- a) 80 and above;
- b) 60 and above;
- c) 40-65;
- d) 20-45 (horses rated 26 and above will alone be permitted to participate during the above said meetings);
- e) Maiden Races, Sweepstakes and Classic races.

3. Application for stable accommodation should be submitted to the office of My.R.C. However, horses which are eligible will be permitted to enter My.R.C. premises up to beginning of the season.

4. All notices and general conditions published in the prospectus for Mysore Summer Races 2025 will be applicable to "B" Licensed Trainers and to their Horse Owners.

5. "B" Licensed Trainers and their Horse Owners shall give undertaking that their horses shall remain in My.R.C. to race under the My.R.C. Ltd., Rules of Racing till the end of the Mysore Summer Races 2025 or till the end of the Mysore Monsoon Races 2025, from the time they enter the My.R.C. Ltd., premises. In case these horse/s fail to participate in at least two races during the above season, service charges as detailed below shall be debited to the account of the Owner/s concerned; If the horse/s does not race at all during the season, Rs.50,000/- and if the horse/s runs only once, Rs. 25,000/-. However, they will be permitted to take their horses to other centers to participate in any other specific race/s, with the prior approval of the Stewards of My.R.C. Ltd.

6. "B" Licensed Trainers shall deposit a sum of Rs 50,000 as interest free security deposit with the Club. In addition to the penalties as mentioned in Clause No. 6 above, a penalty of Rs.25,000/-, if applicable, shall be levied on any horse/s, under the charge of a "B" licensed Trainer stabled at My.R.C. Ltd., if they do not run atleast twice during their stay at My.R.C. Ltd., premises and prematurely leave the premises i.e., before the completion of the Mysore (Monsoon) Races 2025.

7. "B" License Trainers should maintain a minimum string of 5 horses in training and up to a maximum of 10 during the season.

8. The grant of the "B" Trainer's License is solely at the discretion of the Stewards of the Mysore Race Club Ltd., and the Stewards reserve to themselves the right to reject any or all applications without assigning any reason whatsoever


9. All horses arriving at the premises of Mysore Race Club Ltd., should possess the following documents without which they will be strictly prohibited from entering the My.R.C. premises:-

- a. A valid Coggins Test Certificate negative for E.I.A.
- b. A health certificate from the Veterinary Officer of the respective club stating that the horse does not show any clinical signs of E.I.A., Glanders or AHS strangles at the time of its departure.
- c. All the certificates as may be required by the Stewards.
